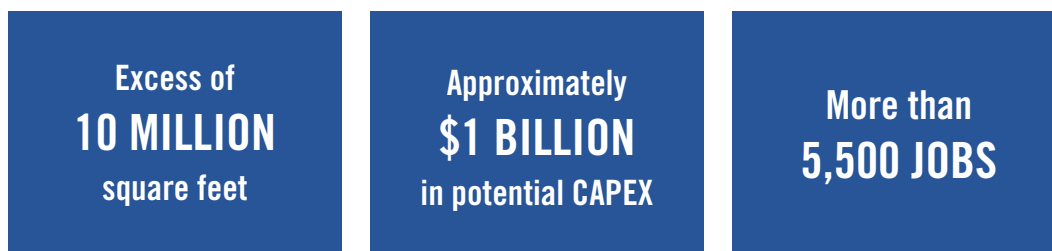

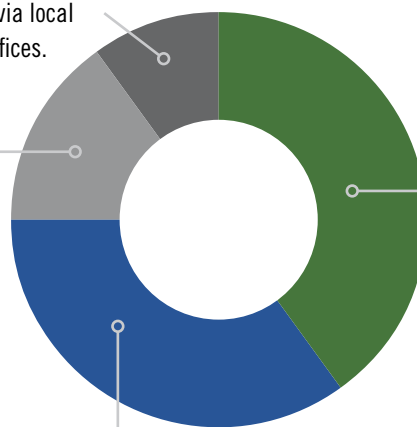

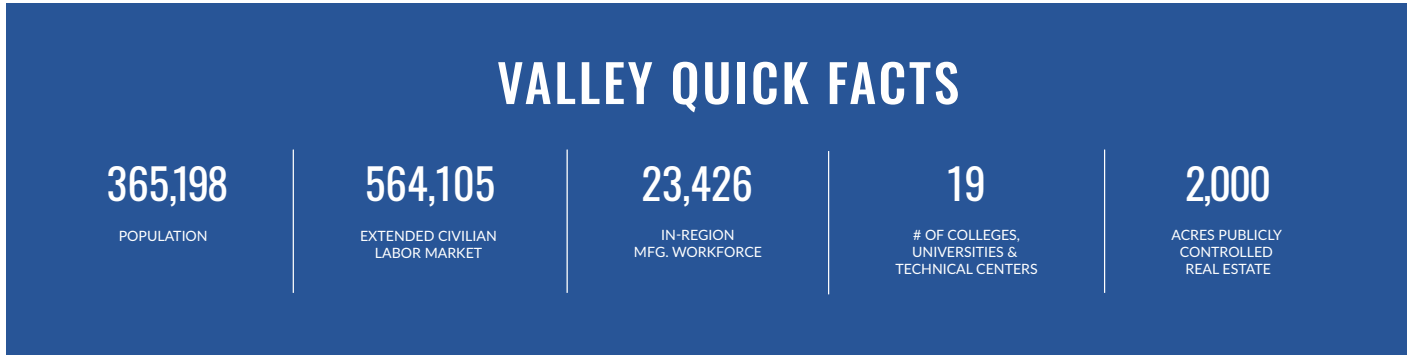

MARKET AND ECONOMIC OVERVIEW

The Shenandoah Valley offers a readily trainable workforce and a powerful cluster of employers rooted in manufacturing, agriculture and logistics. Within a 60 minute drive of the center of the Shenandoah Valley, there's access to a labor force of 348,648 workers, including more than 47,000 veterans and over 125,000 millennials. Four out of five of Virginia's top agriculture producing counties are located here, making the Valley the number one region in the Commonwealth for total value of agricultural products sold. Food and Beverage production is at the heart of the region's manufacturing sector, employing over 16% of the Valley's labor force, more than four times that of the national average. This robust agribusiness and manufacturing fueled economy is also supported by a healthy supply chain of Production Technology & Heavy Machinery, Folding Paperboard Box Manufacturing, Refrigerated Warehousing and Storage, Plastics Products Manufacturing and more.



2016-2017 INDUSTRY JOB GROWTH

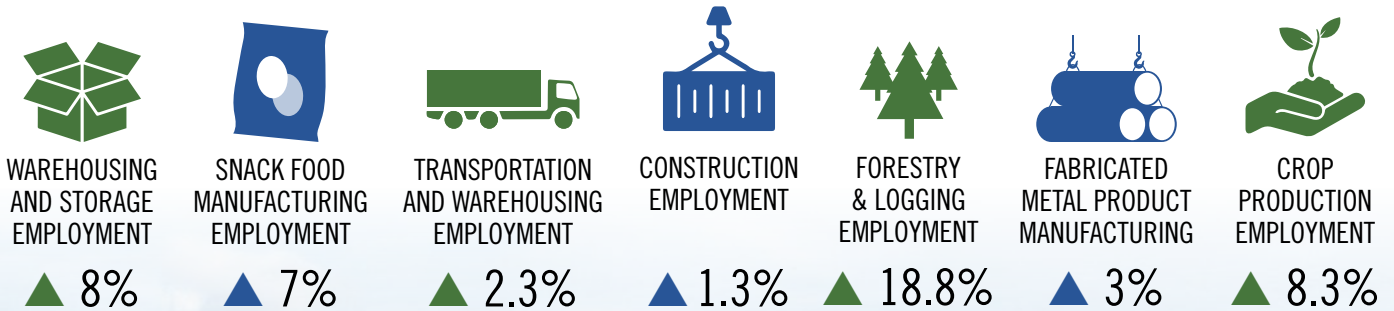
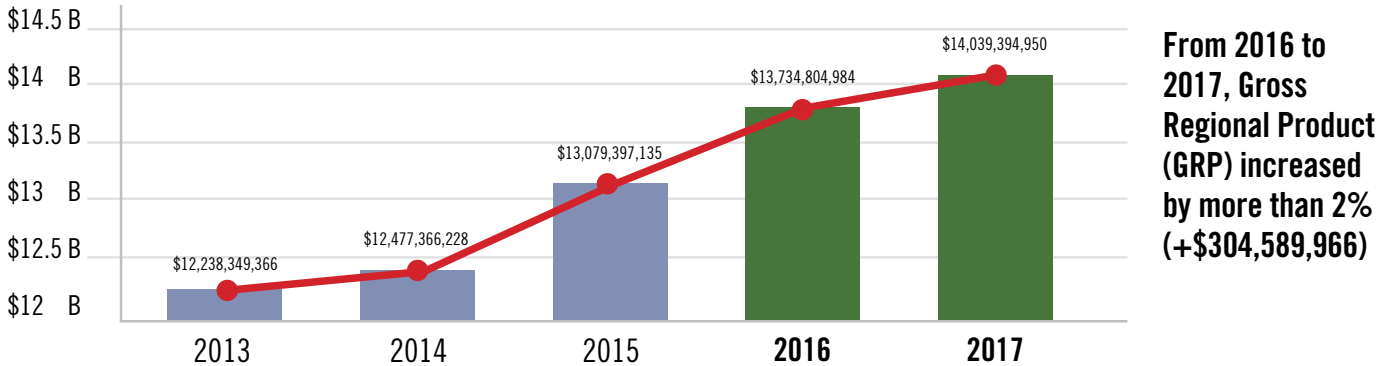

STATE OF THE ECONOMY

In 2017, there were a total of 162,568 jobs in the Shenandoah Valley, an increase of approximately 2,000 jobs relative to 2016. As of December 2017, unemployment in the region was 3.4%, and average earnings per job were \$45.2K. As the number of jobs increased, the labor force participation rate held steady around 58%. As of January 2018, there were a total of 6,789 unemployed people in the Shenandoah Valley, the majority of whom had previous work experience in construction, manufacturing, and retail/food services.

The region's gross regional product (GRP) in 2017 was \$14 Billion. Imports in the region were \$19.7 Billion, and exports totaled \$16.6 Billion. As a share of gross domestic product (GDP) in 2017, animal production & processing, food manufacturing, beverage manufacturing, pharmaceutical medicine manufacturing, and general freight trucking were some of the largest contributors.

C2ER COST OF LIVING INDEX - FIRST QUARTER 2018

The Central Shenandoah Planning District Commission and Shenandoah Valley Partnership jointly fund and conduct the data survey for the Cost of Living Index for the Harrisonburg-Rockingham Metro, Staunton-Augusta-Waynesboro Metro, and the Rockbridge-Lexington-Buena Vista area.

The Council for Community and Economic Research (C2ER) produces the *Cost of Living Index* to provide a useful and accurate measure of living cost differences among urban areas. The Cost of Living Index measures relative price levels for consumer goods and services in participating areas. The average for all participating places, both metropolitan and non-metropolitan, equals 100. Each participant's index is read as a percentage of the average for all places. The index does not measure inflation, and data from different quarters cannot be compared because the number and mix of participants change quarterly.

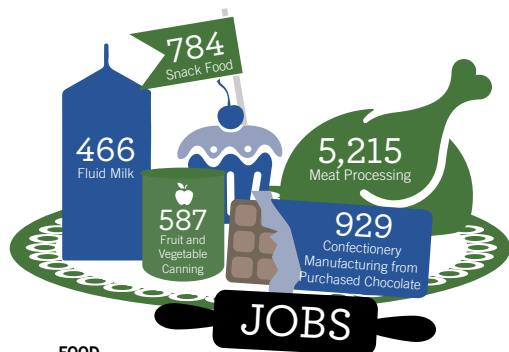

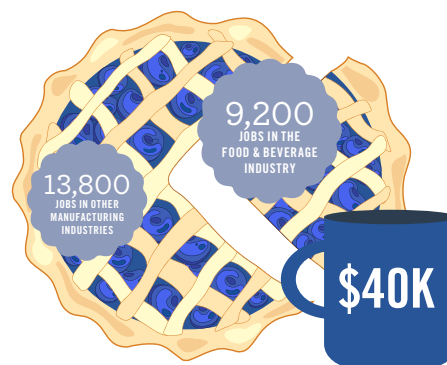
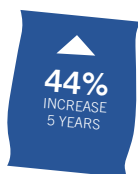


Food & Beverage

The Shenandoah Valley is home to a strong agricultural economy, burgeoning agritourism assets, and deep food and beverage manufacturing expertise.

Agriculture and Forestry

The Shenandoah Valley is home to four of the top five agricultural counties in Virginia producing more than \$1.2 billion annually in commodities sold. Some of the largest clusters of agricultural-related employment in the Commonwealth are located in the Shenandoah Valley. The Valley's employment in Ag & Forestry is 50% above the national average, increasing by 46% since 2010. In 2017, total earnings in Ag & Forestry including wages, salaries, supplements and proprietor income surpassed \$208 Million. Overall, this sector contributed nearly \$350 Million to the Valley's GRP in 2017.



Plastics, Packaging and Printing

From industrial and personal service paper wholesalers to commercial printing, plastics product manufacturing employs over 1,200 people in the Shenandoah Valley, 107% above the national average for a region of its size.



Metals & Automotive

As of 2017, primary and fabricated metal manufacturing employed over 2,000 people in the Shenandoah Valley. Industry employment in the region increased by 2.1% from 2016 to 2017.



HVAC

The Shenandoah Valley is a concentrated employment center for heating, air-conditioning, and commercial refrigeration equipment manufacturing. Twenty-six percent of the state's employment in HVAC equipment manufacturing is located in the Shenandoah Valley, accounting for approximately 900 jobs.



Transportation & Warehousing

Transportation and warehousing employs over 8,000 workers in the Shenandoah Valley, 55% above the national average for a region of its size. Regional employment in this sector increased by 2.5% from 2016-2017, significantly higher than the state average of 0.8%. As of December 2018, there were 380 unemployed people in this sector, 2% above the national average. There are 137 miles of interstate (I-81 & I-64) in the Shenandoah Valley, offering 1-day trucking access to major markets.

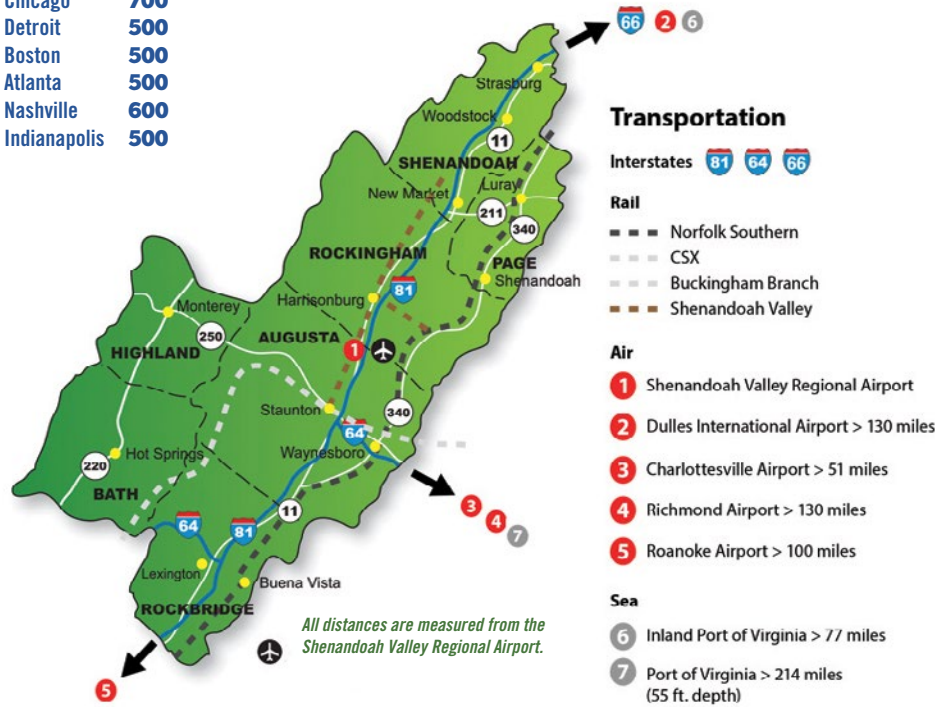

By sea, the Valley has access to the Inland Port of Virginia at the northern end of our market and is 200 miles to the Port of Virginia's terminals in Norfolk. By rail, service is provided by both CSX and Norfolk Southern, as well as two locally owned providers, the Shenandoah Valley Railroad and Buckingham Branch Railroad.



Life Sciences

Medical equipment manufacturing, hospitals, outpatient care, as well as diagnostic laboratories employ over 6,500 people in the Shenandoah Valley. The Valley's employment in the biopharmaceutical sector is 135% above the national average for a region our size.

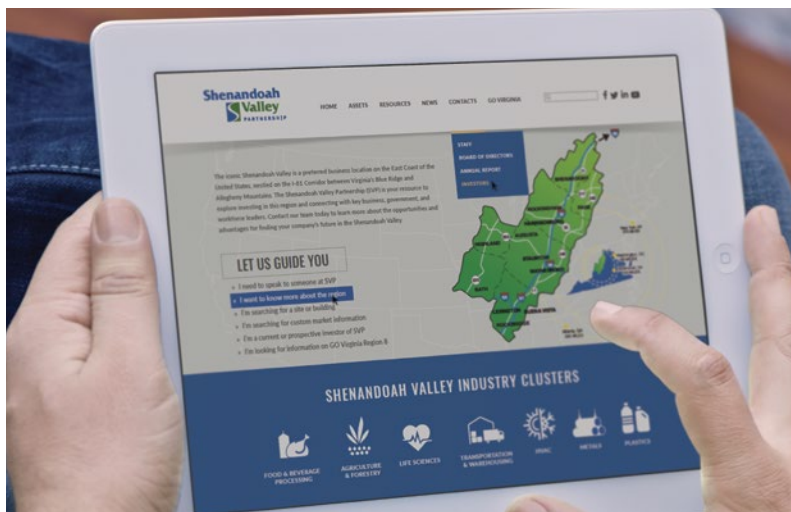

One of nine GO Virginia Regions in Virginia, Region 8 represents the Shenandoah Valley of Virginia and includes the counties of Augusta, Bath, Clarke, Frederick, Highland, Page, Rockbridge, Rockingham, Shenandoah, and Warren; and the cities of Buena Vista, Harrisonburg, Lexington, Staunton, Waynesboro, and Winchester. The Regional Council consists of 28 members and is supported by the Central Shenandoah Planning District Commission (CSPDC) and the Northern Shenandoah Valley Regional Commission (NSVRC). The Council represents small and large businesses, higher education institutions, K-12, local government, and other community leaders.

In the past year, GO Virginia Region 8 funded talent-related projects to provide infrastructure and training to fill high-wage, high-demand industries. In February, funding for the Rockbridge Area Advanced Manufacturing Program (RAAMP) was approved. RAAMP is a 40-week training program for welders at Byers Technical Institute, a new technical training center in Rockbridge County. The program is designed to meet the critical shortage of skilled welders in the region. The \$200,000 needed to implement RAAMP will include a mix of GO Virginia funds and matching public/private investments from the Rockbridge County Economic Development Authority, the City of Buena Vista, and Byers, Inc.

In June, GO Virginia Region 8 announced that funding for the public-private Cyber Security Workforce Development and Jobs Program submitted in round four of project grants to the state GO Virginia Board was approved. This \$200,000 project will allow Blue Ridge Community College (BRCC) to implement a new cybersecurity workforce development program in the Shenandoah Valley to grow high-wage, high-demand cybersecurity jobs. Full funding for this project will include a mix of GO Virginia funds and matching public/private cash and in-kind investments from the cities of Harrisonburg and Waynesboro, BRCC, and a private cyber security partner in the region, InnovateTech.

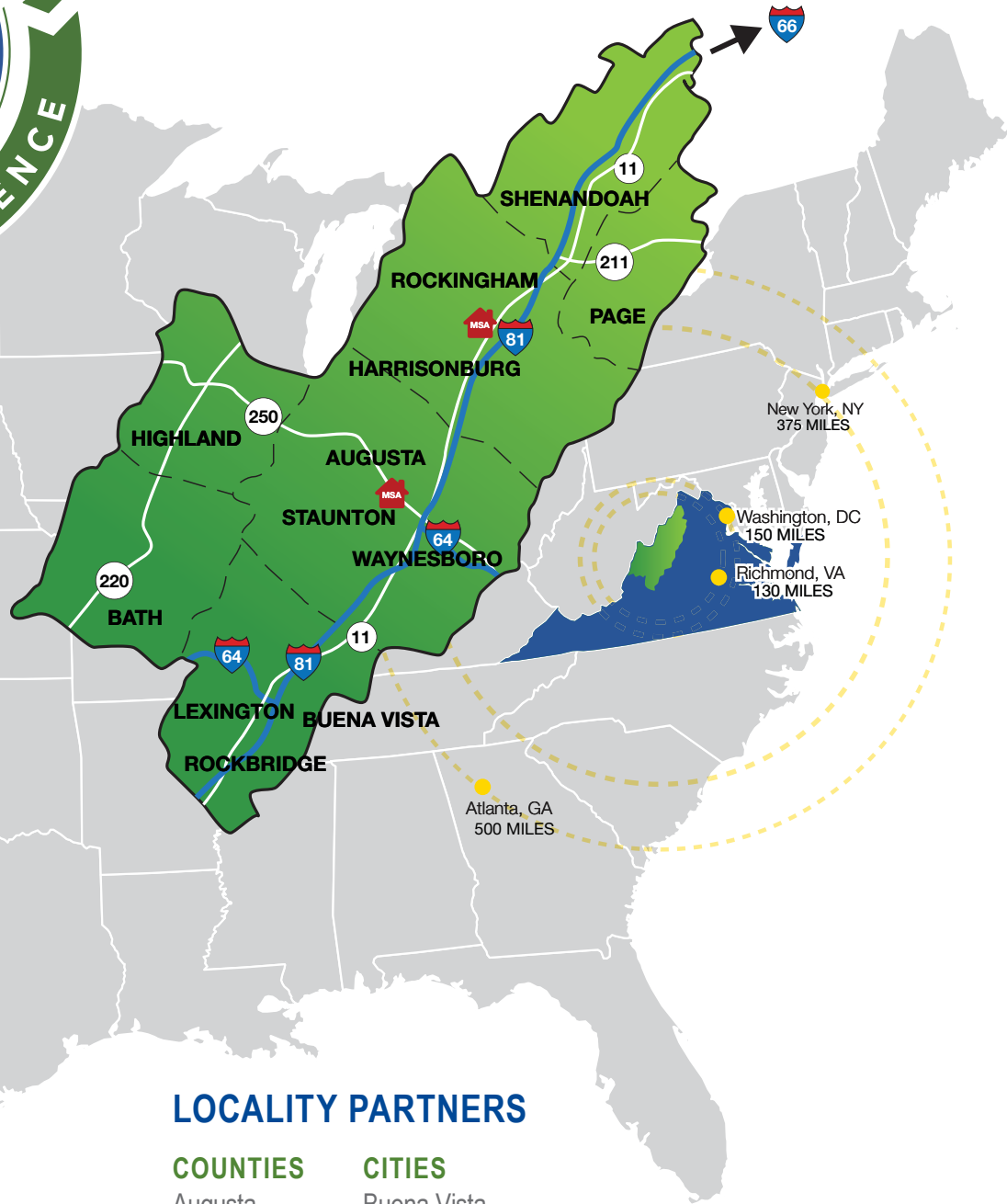
